I. COMPANY PROFILE

Goa Shipyard Limited was created with the objective to manufacture quality ships and hi-tech components for defence and commercial sectors at competitive prices. The GSL is a Schedule - 'B'/ taken over CPSE in Transport Equipment sector under the administrative control of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate offices are at Vasco Da Gama, Goa.

The authorised and paid up capital of the Company is Rs.40 crores and Rs.29.10 crores respectively as on 31.3.2016.

The shareholding of the Government of India in the company is 51.09%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations) is a member of Board of Directors and reports to Chairman and Managing Director. He is responsible for all operations of the company related to shipbuilding, achieving objectives of shippard modernization, and export related issues. He is also responsible for industrial relations interactions and negotiations with unions.
