## I. COMPANY PROFILE

Konkan Railway Corporation Limited (KRCL) was established in the year 1991 under the Companies Act, 2013 with the objective to construct a new Broad Gauge Rail Line between Roha and Mangalore. With the completion of construction of this rail link in 1998, KRCL is functioning as a full-fledged Operating Railway System known as "Konkan Railway".

The Corporation is also executing construction of a new railway line of 53 Kms of the USBRL, Port Connectivity and road tunnel project in Kerala, construction works some bridges and ROBs of Khurda Road- Bolangir new BG Rail Link of ECoR, rehabilitation of meter gauge railway line at Kenya. PMC/ Consultancy/ Inspection works at many locations. KRCL is a Schedule 'A' CPSE in train operation and rail infrastructure construction sector. It is under the administrative control of Ministry of Railways.

Its Registered and Corporate offices are in Navi Mumbai.

The company employed 5507 regular employees (Executives- 248 and Non-Executives- 5259) as on 31.03.2022.

The authorized and paid-up capital of the Company was Rs. 8079.51 crores and Rs.5703.03 crores respectively as on 31.03.2022.

The shareholding of the Government of India in the company is 51%, the Government of Maharashtra is 22%, the Government of Karnataka is 15%, the Government of Goa is 6% and the

Government of Kerala is 6% as on 31.03.2022.

3rd Financial Restructuring proposal is under deliberation at the administrative Ministry (MoR).

## II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government of India. He is responsible for the efficient functioning of the Corporation for achieving its corporate objectives and performance parameters.

## III. ELIGIBILITY

### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

(a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);

(b) Central Government including the Armed Forces of the Union and All India Services;

(c) State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 1500 crore or more**;

(d) Private Sector in company where the annual turnover is **\*Rs 1500 crore or more**.

**Preference would be given to candidates from listed Companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

### 3. QUALIFICATION:

The applicant should be an Engineering graduate/ Post Graduate/ Graduate with MBA/ PGDIM from a leading institute.

### 4. EXPERIENCE:

The applicant should possess cumulative experience/exposure for at least 5 years during the last 10 years in Business Development/ Operations/ Marketing/ Railway Operations & Maintenance/ Project Management in a large organization of repute.

The experience in Contract & Construction and Tech. Consultancy Services/ Railway sector is a desirable experience.

### 5. PAY SCALE:

**(ii) Applicants from the Armed forces of the Union** should be holding a post of the level of Lt. General in the Army or equivalent rank in Navy/Air Force on the date of application.

**Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position on the date of application.

**6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

**IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

## **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

(a) The appointment is on immediate absorption basis.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

### **2. For candidates from CPSE**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### **3. For candidates from SPSE/ Private Sector**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
